Sir,

With reference to your despatch No. 42 Africa of the 5th ultimo (54073/13) respecting proposed regulations to prevent illicit trade in Ivory, I have the honour to inform you that the Soudan Government are prepared to accept a minimum weight of thirty pounds for elephant tusks in the event of the other European Powers concerned agreeing to do the same.

The Soudan Government would further be prepared to declare all Ivory under this weight contraband and, whenever possible, confiscate it, and to make detailed Customs returns showing,
(a) the actual number of tusks of standard size
(b) legitimately exported, and
(c) the total number of undersized and cow tusks confiscated.
