SIR,

I beg to inform you that Mr Frederick Ridley Lingham is desirous of assigning to Mr Charles Sydney Goldman of the Bims, Rottminglean, M.P. and Mr Court Scott Grosan of Camp Hill, Newcastle-under-Lyne, his interest under an Agreement dated the 16th March 1906 and made between Sir Donald Stewart, K.C. M. G. His Majesty's Commissioner for the East Africa Protectorate of the one part and Mr Lingham of the other part whereby the said Sir Donald Stewart agreed to grant a lease to Mr Lingham of certain land situate near the Eldama Ravine in the East Africa Protectorate containing 64,000 acres thereabouts for a term of 50 years from the 1st November 1906 at the rents and subject to the royalties for getting timber and to the covenants and conditions therein contained. I understand that before Mr Lingham can take this step it will be necessary to obtain from the Secretary of State for the Colonies a license for him to do so. Mr Lingham is now residing in Belleville, Ontario, and in his absence I am acting as his Attorney under a duly executed Power. Under the circumstances I beg to request that the necessary License may be given in order that the assignment may be carried out.
