Sir,

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Anstobus's letter (2817/1907) of the 23rd ultimo and the enclosed correspondence in regard to the Agricultural Department of the East Africa Protectorate

In reply I am to request you to convey to the Earl of Elgin their Lordships' sanction for (i) the expenditure (£13,018) provided in the Protectorate Estimates 1907-8 for the Department - which, They note, will be grouped with the Forestry, Survey and Veterinary Departments, each with its separate head, subject to the general direction of the Commissioner for Lands, - and (ii) the salary, £800 - 50 - £1,000 which it is proposed to assign to the Director of Agriculture.

My Lords must however stipulate that for the present at any rate the Director of Agriculture, and the other officials in the Department generally, shall remain on an unpensionable footing, and that this shall be clearly explained to all concerned.

In this extract Mr. Smith points out with great clearness the importance of a properly equipped Agricultural Department to a developing country like the East Africa Protectorate, and, as the Head of one of the largest and most successful institutions of the kind in the world, his views carry great weight. They have been laid before the Governor of the East Africa Protectorate and is an entire accord with them and Lord Algin has no doubts as to their soundness.

Lord Algin fears, however, that there is little or no prospect of creating a really efficient department on the temporary basis suggested by their Lordships; and rather than allow the unsatisfactory state of affairs which has hitherto prevailed to continue he considers that it

would

that an Agricultural Department is essential to the development of the Protectorate but that it will be impossible to provide a really efficient one on a temporary basis, and further that, in a department of this kind will be required for many years to come, an increase in its staff to be made to maintain its efficiency.

In these circumstances Lord Elgin would advise His Majesty's Government that the Director and principal subordinate officials be appointed on a pensionable footing in the same way as in the other departments of the Protectorate.
