TREASURY CHAMBERS,

Sir,

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Antrobus's letter (13494/1907) of the 23rd ultimo in which the Earl of Elgin recommends that the rate for the carriage of chemical manure on the Uganda Railway should be reduced to 1d per ton during the months of July, August, September and October in each year.

In reply I have to say that My Lords see considerable objection, in present circumstances to the introduction, even for a limited period in the year, of a minimum up-rate of 1d per ton mile for goods on the Railway - the existing minimum up rate being 1d - or to extending, pending further experience, the concessions agreed to by Treasury letter (6767/07) of the 8th instant which may involve an immediate loss in revenue of £5,000.

My Lords do not understand, from the 1<sup>st</sup> paragraph of Mr. Currie's letter of the 12th March, that the down traffic in the months named is actually in excess of the up traffic or that wagons have to be sent up empty for the purpose of accommodating the down traffic.

It further appears to Their Lordships that for the purpose of affording relief has been given to chemical manures by their exempting them from Import duty.
