With reference to your despatch No. 397 of September 1st, enclosing a circular on the subject of the adoption of a new white undress uniform to be worn by officers of the Colonial Civil Service in tropical countries, I have the honour to state that the adoption of this uniform would be highly appreciated by those officers in the East Africa Protectorate who by their position are obliged on occasions to wear the ordinary civil uniform which is quite unsuited to a hot climate like Mombasa. These officers are the Commissioner (2nd Class), the Deputy Commissioner (3rd Class), and the Assistant Deputy Commissioner, the Sub-Commissioners, the Treasurer,

the Manager of the Uganda Railway, the Principal Medical Officer, the Head of the Marine Department, the Inspector General of Police, and the Chief of Customs (4th Class).

2. With regard to the white Protectorate uniform,

I have the honour to report that in accordance with the regulations on this subject which have from time to time been published no officer drawing less than two hundred and fifty pounds a year is entitled or required to wear it. There are three classes which are divided as follows:- The officers enumerated in the Table of Precedence published in the Official Gazette of July 15th 1904 from three to fourteen (excluding Nos. 4 and 5) belong to the first class and wear oak leaf shoulder straps, those from sixteen to thirty (excluding No. 17) belong to the 2nd class and wear shoulder straps with two loops, and those from thirty-two to forty belong to the third class and wear shoulder straps with one loop.

3. I am of opinion that the present uniform might be

simplified


simplified by abolishing the sword. This is the only item of expense, as the shoulder straps, buttons and badge together only cost about two pounds. Officers would do well not to purchase more than one or two white uniform suits and mess jackets in England as they are cheaper and generally better made locally.
