MEMORANDUM.

I have again been in communication with the Manager of the Mombasa Branch of the Bank and he informs me that the Bank's rate for the accommodation to the Public varies from 5% to 8% according to circumstances. He further informs me that it is quite impossible for him to make even a rough estimate of the amount which might be employed in affording accommodation in the Protectorate as every thing is more or less in an experimental stage and there are no settled industries in the country.

Our object of allowing certain balances to accrue in the Protectorate with the Bank without interest is to enable the Bank to keep a reserve of cash in hand which would be available in times of emergency though this necessity would be partially obviated if the Currency Commissioners were allowed to temporarily deplete their cash reserve. Further owing to the few Government drafts now-a-days negotiated by the Bank - which is essentially an exchange Bank - the Bank obtains but little profit from the Government account. The Manager considers that the adoption of some such proposal as suggested would be no more than adequate remuneration for keeping the Protectorate account.

As the local Bank Manager cannot enter into any agreement without the consent of the London Office and as the Colonial Office do not see their way to approve of your original recommendations conveyed in your despatch No. 419 of 4th October 1907, I would suggest that the whole matter be arranged in London through the medium of the Crown Agents who would draw up a fresh agreement with the Bank.
