Sir,

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Anonbus' letter of the 12th ultimo (3925/1909), relative to the appointment of Lieutenant J.A.G. Elliot, Reserve of Officers, as an Assistant District Commissioner in the East Africa Protectorate with salary at the rate of £250 per annum.

As the Earl of Crewe is aware, no abatement from pay is required to be made under No.4 of the Rules under section 6 of the Superannuation Act, 1887, unless the non-effective pay and Civil emoluments together exceed £400 a year. Unless, therefore, Lieutenant Elliot receives additional emoluments from the Protectorate Government as well as his salary, the question of abatement does not at present arise in his case, as My Lords understand that his retired pay (excluding wounds pension, in accordance with Rule 1 (a)) only amounts to £80 a year.

In the event, however, of Lieutenant Elliot's total emoluments hereafter exceeding £400 while he remains in the service of the Protectorate, I am to request that the Secretary of State will cause an abatement to be made from his Civil emoluments (subject to the limitations laid down in Rule 4 (a)) at the rate of 10%, unless his Lordship considers that a higher rate will be more appropriate.
