Sir:-

With reference to my note of July 14th to Count Salsoroff, relative to the proposed journey of Count Salm-Kallferscheid through Egypt to Benghazi, I have the honor to inform you that I have received a despatch from His Majesty's Acting Agent and Consul General at Cairo reporting that he communicated to the Egyptian Ministry of Finance and to the Sudan Agency the necessary request for facilities.

Mr. Neethan states that due note has been taken of this in both those Departments but that it would be well if His Majesty's Agency and Consulate General could eventually be apprised of the exact date of Count Salm's arrival in Egypt.

With regard to the Sudan, every facility will be readily accorded to Count Salm during his journey, but

the Sudan Agency will require to know the details of his itinerary in order that arrangements may be made for his accommodation on railways and on board steamers

It would also be advisable that Count Salm should, on his arrival at Cairo, send a representative to the Sudan Agency with a complete list of all arms and ammunition accompanying him in order to apply duly to the necessary permits.

As regards the British possessions in the Sudan, which Count Salm desires to visit, I have the honour to state that, in the view of His Majesty's Government, the facilities for the visit of his Majesty's subjects to the Sudan are generally such as to be in accordance with the principle of reciprocity, in so far as the facilities, strictly in the merits of each case, are not inferior to similar facilities generally accorded to British subjects by the governments of the country to which the applicant belongs and that the principle of reciprocity is thus duly safeguarded. would of course be taken on both sides to prevent any abuse of the privileges so granted.

I have accordingly the honour to request that I may be favoured with further information respecting the nature and objects of the expedition which Count Salm proposes to undertake.
