Sir,

In reply to instructions contained in paragraph 11 of the Colonial Office despatch No. 189 of 6th April 1906, I have the honor to state that the site of the ~~wharves~~ terminus at Kilindini does not lend itself to a ~~site~~—the configuration of the fore shore is more suited to wharves and although for reasons of economy shallow water wharves ~~have~~ been heretofore advocated there is no serious difficulty in providing wharves in deep water. No scheme has up to the present been submitted for wharves in deep water but Mr. Currie took home with him plans showing a site on which they could be erected.

Most of the information required is exhibited and enough given to determine the site and afterwards design the wharves. I have no manner of doubt that with Mr. Currie's valuable aid the business can be satisfactorily settled in ~~London~~. Mr. Church the Superintendent of Works supports this statement. I would add that the accommodation suggested in the Colonial Office despatch viz berths for two large steamers at one time must be so laid out that it may form part of a larger provision

provision in the future. No further survey would at present appear to be necessary. Sufficient has already been done to enable the project to be entered, but a more detailed survey of the site agreed upon could be made as soon as the nature of the works have been settled. I do not anticipate that any such survey would entail any heavy expenditure.
