

Sir,

I am directed by Mr. Secretary Thomas to call attention to the recent Companies Ordinance of Uganda (No. 22 of 1955) and to point out that there are now some minor divergences between the companies' legislation in force in the three territories of Kenya, Uganda and Tanganyika.

2. In legislative measures dealing with such things as commercial companies the greatest possible uniformity is desirable, and it is suggested that the question should be brought before the next Law Officers' Conference with the aim of amending the Ordinances so as to provide not generally similar but absolutely identical legislation in the three territories. It may be that such an aim is impossible of attainment owing to local divergences, but the Secretary of State is of the opinion that the question should be examined and the differences, which are not of great importance, reconciled, if possible.

LEGAL REPORT

THE COMPANIES (AMENDMENT) BILL, 1934.

This Bill is designed to amend the Companies Ordinance, 1933, in two respects -

(a) by repealing sub-section (5) of section 79 of the Ordinance which deals with charges comprising property situated outside the Colony. The provisions of sub-sections (3) and (4) as to these charges make the retention of this sub-section unnecessary;

(b) by altering the requirements of section 168 as to the printing of the names of directors of companies on the companies' stationery, etc. Power is given to the Registrar to grant exemption from the provisions of the section, and to a Judge in chambers to hear appeals from the Registrar's decision on such matters.

The amendment referred to in (b) supra has been made at the request of the Chambers of Commerce. It was represented by them that the costs involved in making an application to a Judge of the Supreme Court were heavy, and that the Tanganyika Ordinance provides for such application to be made to the Registrar of Companies. In the circular annexed it has been considered desirable to amend the Principal Ordinance to bring it into line with the Tanganyika law.

A Comparative Table is attached.

ORDINANCE No. XX of 1934

An Ordinance to Amend the Companies Ordinance, 1933.

ENACTED by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof, as follows:—

1. This Ordinance may be cited as the Companies (Amendment) Ordinance, 1934, and shall be read as one with the Companies Ordinance, 1933, hereinafter referred to as the Principal Ordinance.

2. Section 79 of the Principal Ordinance is hereby amended by repealing sub-section (5) thereof

Amendment of section 79 of the Principal Ordinance. Particulars with respect to directors in trade catalogues, circulars, etc.

3. Section 146 of the Principal Ordinance is hereby amended by repealing sub-section (1) thereof and by substituting therefor the following:—

146. (1) Every company to which this section applies shall, in all trade catalogues, trade circulars, show-cards and business letters on or in which the company's name appears and which are issued or sent by the company to any person in any part of His Majesty's dominions, or in any country under the protection of His Majesty or in respect of which His Majesty has accepted a mandate, state in legible roman letters with respect to every director being a corporation, the corporate name, and with respect to every director being an individual, the following particulars:—

- (a) his present Christian names or the initials thereof, and present surname;
- (b) any former Christian names and surnames;
- (c) his nationality, if not British;
- (d) his nationality of origin if his nationality is not the nationality of origin;

Provided that if special circumstances exist, which render it, in the opinion of the registrar, expedient that such an exemption should be granted, the registrar may grant, subject to such conditions as he may specify, exemption from the obligations imposed by this subsection.

Any person aggrieved by a refusal to grant an exemption under this sub-section may appeal to a judge of the Supreme Court sitting in chambers.

Passed in the Legislative Council the twenty-seventh day of April, in the year of Our Lord one thousand nine hundred and thirty-four.

LEGAL REPORT

THE COMPANIES (AMENDMENT) BILL, 1933.

Under section 324 of the Principal Ordinance every company, including a private company, is required to submit annually to the Registrar a balance sheet. The law is the same in the United Kingdom, but in actual practice the authorities there do not require private companies incorporated outside Great Britain to comply with the provisions of the law. As it is not intended that private companies incorporated outside the Colony should annually submit a balance sheet to the Registrar it is considered desirable to amend the local law, and this Bill effects the necessary amendment.

In my opinion, His Excellency the Governor may properly assent to this Bill in the name and on behalf of His Majesty.
