1. The object of an advance to Afmadu would be to exercise a more immediate control over the Ogaden Somalis, such control being enhanced by the pessession of the wells at Afmadu which it is presumed the garrison at Afmadu could deny at will to the Ogaden.

The possession of the wells would only be effective in the dry seasons when other watering places were not available, in the wet seasons, the occupation of Afmadu would be of no effect.

The wet seasons in Jubaland seem to vary in intensity and duration and therefore the effectiveness of the occupation of the Afmadu wells varies with the amount of rain.

For the present I am inclined to recommend that matters remain as they are, offences against law and order on the part of the Ogaden can be very effectively met by the re-imposition of the blockade which so successfully operated from 1902 onwards and ended in the Ogaden paying their rines in full.

At present the Ogaden want peace and give no trouble, the Abyssinian raiders have not so far touched them, and the question of protection from Abyssinian raids has not arisen.
