I having not satisfied at the
 reasons as to the following claim
 made against the British East Africa Pro-
 tectorate, made by the H. M. S. Co-
 mmissioner, I must hum-
 bly beg to apply your honour to
 kindly inquire into the matter &
 see them obtained me.

I have been not paid for a day
 by the Postmaster General,
 London to which I was fully
 entitled. The fact was that at the
 time I resigned my post as Post-
 master & the period of my resignation

was received on the 2nd September 1904
 my relief arrived there on the 1st
 and is received by the headmaster at
 11.30 a.m. settlement on the 2nd
 the train available for that day
 his instructions about handing
 charge to my relief were sent in
 the 1st of September General till 10.12
 on the 2nd (for which proof a
 copy of the telegram is with me) as
 the train had been passing
 11.30 a.m. before 6.0 a.m. (at
 11.30 a.m. the train service was then
 suspended) therefore I was forced to
 catch the next train avail-
 able on the 3rd. I reached Mombasa
 on the 5th & I was paid up to
 1st September 1904. I was leaving
 for the north when I left the
 office.
 That I was not paid my Railway

quire into the cost of my return
from Bombay to Bombay
collected from me by the
Postmaster General at the time of
accepting my resignation & to send
me to know whether it was
fully or not? The fact was as
follows.

That I was bound in agreement
to be employed as Post & Telegraph
officer in the Post & Telegraph De-
partment of the District Post office
at Bombay for the space of three
years on the 15th of March 1900 &
performed the service for three
years & three months since I left
on four months' leave before

arrived in India after passing
 a period I returned to Bombay
 resumed duty on the 22nd May 04
 I resigned the service on the 2nd
 Oct 04 at a month's notice (I
 was about three & half months
 to I being relieved from the
 service)

I shall be highly obliged if you
 kindly explain me that upon
 my service after I being
 relieved from the leave I would
 be entitled not to refund
 cost of my return journey to
 Government?

Also you will be good enough
 let me know whether the cost
 of my return journey, refunded
 was applicable under the
 terms of an agreement or under
 decision from the Postmaster
 General?
