JORDAN

Beritan
 Are still slightly divided as to fine. Odein Mahomed and
 Meraengeli are not on the DBMEM.

Reported that Sheikh Ali Nasir's murderers are
 living in DAJJABA itself. The Italian Officer at PANJERA
 employed them recently to recover from the Beritan the
 looted property of Sayid Salim Aish (vide Intelligence
 Report for February).

Brought in 60 men, 19 of which were laden with
 cloth etc.

Italian Officer gathered them with 100 rounds shell
 and 80 rounds of cloth.

No rumour that Abdilah el Lab (one of Sheikh Ali
 Nasir's murderers) and a Beritan actually murdered

W.L.A. Sheikh Ali.

Ogadene.

... the Sultan of Zanzibar, who had been captured by the Mullah's forces.

According to Mullah, the Mullah should be regarded as having that Sultan Omer Mohamed was buried in a tomb at SUA (SOMALIA) long ago. The Sultan had given his permission to the Mullah.

The position of Sultan Omer Mohamed, according to the Mullah's petition, is as follows: On 1st July, capturing a large number of Sultan's men at about 10 men. That party then returned to their headquarters.

Sultan Omer Mohamed sent to Sultan Yusuf Ali at SUA asking him to send a force of 500 men from the northern part of the country against the Mullah.

Sultan Yusuf Ali collected all his people and is prepared to move.

Reported that 8 Italian Officers arrived at SUA (SOMALIA) on the 1st of February with horses to be supplied to the Mullah. In reply Sultan Omer showed the Italian Officers the corpses of 4 Aissa Malamud, who had just been killed by the Mullah's forces.

The Italian Officers were left SUA (SOMALIA) with 8 passengers to the Finianal at Djibouti (AFRICA) and 66.1 MM Long. 45.5 E. until 19th 50 hours 10 min of cloth and point, with the idea of establishing bases against the Italo-Somali.

Reported that the Sultan had sent up regular to the Mullah asking for rifles and that the Mullah himself or a party of his men are sending word to assist the Finianal.

In addition to the intelligence unit in Kripatris, so-called Spring or Spruce Stage, to report that it is operating Kripatris for the tribe in areas although very little is yet paid but each competitor message to all the people to sell their lives which as rinderpest is everywhere is their only property.

There are rumors that the Chinese and the Russians will work for Kripatris - nothing the town is closed which government does not intend to enforce them do just to itself thus not be able to give through.
