My Lord,

With reference to Your Lordship's despatch No. 374 of July 5th informing me of the appointment of Mr. J. S. Forsyth as an Assistant in the Native Affairs Department, I have the honour to report that I have temporarily transferred that officer to the Administration, under Section 2 Paragraph 2 of the new Rules for the employment of officers. My reason for taking this step was in accordance with the principles expressed in my despatch No. 173 that an officer new to the country would, it appeared to me, be of very little use in the Native Affairs Department, in which a thorough knowledge of natives, their language and customs is necessary and I trust that my action in the matter will receive Your Lordship's sanction. I venture to suggest that, in future, in order to give a freer hand in the matter of

transfers, all Assistant in the Native Affairs Department should be described as Assistant District Commissioners and included with them in the Estimates.

2. There is no real reason why they should be shown separately, as Your Lordship has decided that the Native Affairs Department is merely to be shown as a sub-division of Provincial Administration. I propose, subject to Your Lordship's approval, to adopt the same course in the case of Mr. Deacon as in that of Mr. Swarth.

3. The question of the ultimate employment of both these officers in the Native Affairs Department will, I presume, depend on the aptitude they display for such work, demanding as it does special qualities, the absence of which would not however necessarily render a man unfit for useful service in other branches of the Administration.
