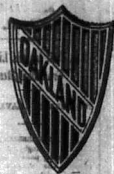

HILL SITE FOR NEW GOVERNMENT OFFICES.

Opposition by the Town Council.

ENGINEER'S POSITION.

A matter of urgency was introduced by the Deputy Mayor, Mr. L. J. at the consideration of the ordinary business of the Town Council on Tuesday. It had been agreed some time before, said Councilor Lay, that the Municipal Engineer, Mr. Davidson, should set up to any more sub-committees without the consent of the Municipal Council. He already represented the Town Planning Authority to the Town Government Offices on Secretariat Hill, and it had been proposed that Mr. Davidson should be on that Committee. The formal consent of the Council was required. Councilor Brown strongly opposed the suggestion as he said that the Town Planning Authority had proposed that the Government Offices and if the Council was allowed to go on to the Committee it might be thought that the Council was in agreement with the suggestion.

Councilor Why said that the Government had definitely decided to put the offices on the Secretariat Hill and that it was not a question of the exact position of them.

It was hardly a question of a decision but rather that Government should be present at a meeting with the Municipal Engineer to go into the detail of the site and to put out any objections.

A Dodge.

Councilor Brown mentioned that the suggestion of a sub-committee was not the part of Government to make it clear that the Municipal Engineer was not to be appointed in the way of a sub-committee but that it was up to Government to submit plans to the Town Council.

The meeting then was held in the Council Chamber on Tuesday. Councilor (Laid) proposed that the Town Council be divided into sub-committees to deal with the Secretariat Hill. He said any benefits would come from the Municipal Engineer being a member of the suggested sub-committee and that the Municipal Engineer's services were always available to supply any information or assistance regarding the site on the hill.

This was agreed to by the Council.

City Park Road Limit.

With a view to the preservation of the roads in the City Park which obviously for some time cannot be met up on a proper basis, it has been decided by the Town Council that a speed limit of 12 miles per hour should be imposed on any roads within the City Park boundaries.

Municipal Roads.

ITEMS IN THE ENGINEER'S REPORT.

The following road report for the fortnight ending March 9 was submitted to the Town Council on Tuesday.

Workshops Road.—This road from Whitehouse Road to the P.W.D. Office was completed and opened to traffic on Monday.

Victoria Street.—Work was commenced on Feb. 27 consisting of the laying of the surface has been started at the River Road end.

Atieno Buildings Area.—The Contractor has completed laying the foundations for Gorman Road and has started on Dada Road. Masonry is going on the following roads:—Swamp Road, Davao Road, Araba Road and Station Road.

During one of the report Councilor Gaster asked whether any one was attached to the road provision was being made for carrying off the surface water in Victoria Street. It was agreed that the matter should be brought up at the next meeting of the Works Committee.

Councilor (Laid) drew attention to the fact that some holes had been left in the road near to the Central Hotel and were unattended. The holes had been filled with three feet by two feet.

The Deputy Mayor (Councilor Laid) said that he did not know by whom the holes had been made, but thought it might have been the Works Department. In any case they would be attended to.
