Agency Estimates 1910-11

I have talked these estimates over with Mr. Simson. You will see from the attached notes by him that he does not agree with all the remarks made by Mr. Wilson in his covering letter. Our principle must be, I think, on points on which they do not agree, to follow Mr. Simson rather than his temporary substitute. To do otherwise would be unsafe, as Mr. Wilson's experience is very brief, and it would not be fair to Mr. Simson.

You will see that Mr. Simson is not satisfied that the increases in the salaries of all the clerks are necessary. I gather from his notes that he has recommended that the Head Clerk and the Second Clerk should be left at last year's salaries, that the 6th, 7th, and 8th Clerks should get the increases suggested for them, because clerks are engaged on the understanding that they rise to Rs. 40 a month if their service is satisfactory, by increments of Rs. 5; and that the increases to the 3rd, 4th, and 5th Clerks should be approved on the ground of increased responsibility. But according to Mr. Simson's own notes, the increased responsibility was met by a general move up ^{towards the end of last year} in connexion with the suggested appointment of a new clerk who was to have been appointed at Rs. 80 but was actually appointed at Rs. 30, the vacancy being thus in practice filled by the promotion of the 3rd Clerk and those below him. I would therefore cut out all the increases, except those of the 6th, 7th, and 8th Clerks, which are apparently necessitated by the terms of their agreements. This means a saving of Rs. 35 a month in salary and Rs. 2½ a month in allowances, that is of about £30 a year.

We may agree to the increases for the Sepoys and other subordinates. It is clearly necessary to approve of the higher provision for rent. The other items under the head "Other Charges" call for no comment.

? Approve of the estimates with the reduction mentioned above, and send a copy of the correspondence and of the estimates to the Protectorates concerned.

Note on the Estimates for 1910/11 submitted
by the Bombay Agency.

Establishment. (Items 1 to 14 of the Estimates). - By Colonel
Office letter N° 45127/1909 dated the 2nd December/08
the engagement of a superior Clerk on Rs. 80. - to Rs. 100
per month was sanctioned but difficulty was
experienced in finding a really competent man.
It was therefore decided to endeavour to further to
develop the usefulness of the Clerks already in the Office
by giving them further training & increasing their
responsibility. - The scheme proposed success and
instead of a Special Clerk on Rs. 80. - to Rs. 100. - per month
a grant was engaged on Rs. 30. - per month and small
increases were granted to those upon whom greater
responsibility devolved. - The result is the salary
pointed out in para 3. of Bombay letter N° 11 dated
the 24th Sept. 1909. - I do not enclose all the
increases in pay suggested in the Estimates,
necessary since the Head Clerk and the 2nd Clerk
have already reached their maximum salary,
but it may be desirable to grant the increases
for the others - either on the ground of increased
responsibility in their work or in order to conform
to the terms of their engagement which usually
 stipulate for an annual increment of Rs. 5.
The month up to Rs. 40. - has been satisfactory
is given. - There is no system of promoting one
Clerk yearly, as suggested in the concluding para
of the Bombay letter, as the records will show.
The pay of the Head Clerk (whose increase this year
is a special sanction of Lord Curzon), the 2nd Clerk
and the 3rd Clerk have been stationary for many
years of 2 months and though I am unable to give
details having no records in this

The pay of the Scribes (Items 10 to 14 of the estimate) I have already mentioned to Mr. Read, in conversation, and I consider that the suggested increases on the heads are fully justified.

Office Rent (Item 15 of the estimate) The position was briefly explained in a note accompanying the estimate for 1909/10. - It is only worth mentioning to the Office premises and are paying at present over the rent that was paid some years ago. At the time it was paid it was in my opinion over 50% above the normal rent at that time being Rs. 225 - per month (instead of Rs. 175. - paid), and rates have since gone up. A demand for increased rent might be made at any time and it would be desirable to sanction the rate suggested leaving it to the discretion of the Officer in charge of the Agency to make the best time possible and if necessary to move to other premises. In case of notice to quit being given there would probably be no time for reference.

Postage, Telephone (Items 16 to 18 of the estimate) I am not in favour of the suggested reductions in these headings and the last amount was, I consider, in cases of emergency more than repair into cost.

Strength of Office Staff (Concluding remarks of final para. of Bombay letter) The Staff is in my opinion by no means unnecessarily large to carry on the work efficiently and I should be very loth to undertake the responsibility with smaller or less competent assistance. I am informed that the present list of books (including the Journal, the Boarder Sheet, the Letter Register, etc.) and several Records which I consider of the highest importance. - In my opinion

Estimates for the year 1910-1911.

Sir,

In submitting the Estimates for the year 1910-1911 I have the honour to make the following remarks for the information of the Earl of Crewe.-

- (1) I have added the allowances sanctioned by His Lordship to the salaries of the clerks in question.
- (2) The increases in salary have been added this year to enable all the clerks to pay house rent, which instead of decreasing seems to be increasing yearly. This is subject to approval of His Lordship.-
- (3) Item No. 8 - A special clerk on a salary of rupees eighty to one hundred per mensem was sanctioned by His Lordship in accordance with despatch No. 48127/1909. The clerk appointed was engaged on rupees thirty six per mensem which included the usual allowance, and a sum of rupees six per mensem was added to the salary of the 3rd clerk, and rupees six to the 4th clerk, making a total expenditure of rupees forty eight per mensem and a saving of rupees fifty two per mensem out of the sanctioned allowance of rupees one hundred.-

(4) The menial staff have all been entered in the estimates on an increased salary of rupee one each per mensem plus the usual grain allowance. Should however it be decided by the Government of India that the above allowance is to be discontinued, there will be a saving of rupees twelve per mensem or £ nine per annum. I respectfully beg that the office peons etc., be granted the increase in salary as each man has to pay rupees four per mensem for house accommodation.-

Item No. 15. Office rent. The Estimates last year allowed rupees

two hundred per mensem, up to the present we have been paying rupees one hundred and seventy five only thus saving rupees three hundred per annum. It is more than likely from what I hear that the rent this year will be increased and the full sum demanded viz. rupees two hundred and twenty five. I have entered this latter sum so that in case the rent is increased special sanction will not have to be asked for after the Estimates are passed. Should however the rent remain at rupees one hundred and seventy five, a saving of rupees six hundred per annum will be effected. As far as offices go, another building like the one we are in at present could not be rented for rupees two hundred and twenty five per mensem.-

Items Nos. 16 & 17. I think should be reduced in a measure and more economy exercised as regards stationery - there is no necessity to use such superior paper etc., for ordinary purposes except for correspondence with the Colonial Office and the Governors of the Protectorates.-

Item No. 18. Telephone. Personally I should withdraw this item as our office is very centrally situated and within easy distance of all the Principal Government Offices in Bombay which we have to deal with.-

In conclusion, I respectfully beg to state for the information of His Lordship that some definite arrangement should be made regarding the salaries of the clerks - promoting each clerk yearly will add considerably to the expense of this office. The salaries of the head, and second clerk should be fixed so that they will know exactly what to expect and look forward to. All others should be on the temporary list with a fixed salary so that when joining the service they will know exactly what is before them. Personally from what I judge there are too many clerks but it would not be quite correct on my part to interfere with, or upset existing arrangements made by Mr. Simson.-
