My Lord,

I have the honour to refer to Your Lordship's telegram of the 5th of October last and my telegraphic reply of the 7th of October.

2. Until I have been able to consider thoroughly the whole question of the reorganization of the Police Force I do not wish any additional staff appointed, but I fear that the delay is inflicting a certain amount of hardship on certain Inspectors who may fairly consider themselves as on the Permanent staff but whose conditions of service have not been definitely settled.

3. I would therefore invite a reference to my despatch No. 529 of the 24th of June last and ask


5. There remain the cases of Inspectors Anderson, Bowen and Milton, and of Assistant Inspectors Ward and Lydford.
