IDS Profile

Established in 1965, the Institute for Development Studies (IDS), University of Nairobi, is the oldest of 20 such institutes in the world. It is the premier multi-disciplinary and a multi-purpose development research institute in Eastern and Southern Africa region. IDS carries out full time research on high priority areas of social-economic and political development in Kenya, Africa and the world in general.

IDS has increasingly influenced policy thinking and policy making. In addition, IDS has collaboration and linkages with many research institutions and universities across the world. The Institute has engaged in a variety of research projects relevant to Kenya's development agenda. It uses seminar series, workshops, and publications to disseminate and get feedback on research results. The publications include policy briefs, working papers, discussion papers and finalized research papers.

Courses Offered

MA PROGRAMME

The Institute for Development Studies' master's programme addresses development issues using theories and methodological approaches of various academic disciplines. The courses, however, assume some formal study of practical experience in the social sciences. The curriculum takes advantage of the varied academic background and experience of IDS staff to offer a programme characterised by theoretical rigour, emphasis on research methodology, people orientation and an interdisciplinary issue-based approach.

The post-graduate programme in development studies prepares students already grounded in the social sciences to deal creatively and effectively with development problems. All courses take a multi-disciplinary approach; all combine theory with practical application. The problems of development in Africa are stressed. Every course includes examples taken from the Kenyan situation.

The core of the programme consists of four courses taken by every student. Courses 501 and 502. Development Management, provide the theoretical underpinning for all course modules courses 503 and 504, Research Methods and Techniques, give students the technical skills required to gather, present and analyze data on development problems. The following fifteen (15) courses were offered in 2013:

Core Courses

CDS 501: Development Management Theory

The concept and goals of development, Economic, political-economy, Sociological approaches to development. Development models: growth, distribution and diffusion, dual economy, underdevelopment. Current issues and concerns in development: gender, environment, culture, human resources, roles of government and private sector in resource mobilization. Development strategies: big push, balanced and unbalanced growth, employment, trade, agriculture, industrialization, basic needs, sustainable development. Barriers to development. Development planning and management.

CDS 502: Development Management Practice

Project preparation, analysis, evaluation, and monitoring. Project conceptualization and planning: technical, institutional-organizational, social, economic, environmental, and financial aspects. Project implementation: project development, project proposal, budgeting, staffing, sitting, strategies for implementation. Project evaluation and monitoring: cost-benefit analysis, qualitative evaluation, monitoring and assessment.

CDS 503: Research Foundations

Conceptual and methodological foundation for research. Research design theory, hypothesis, data requirements. Planning for analysis of subgroups by gender, location, sector. Model formulation. Introduction to computers and their applications in research. Methods of data collection: surveys, participant observation, case studies. Questionnaire

design. Interview techniques. Ethics of social science research. Methods of data analysis. Research report writing and presentation.

CDS 504: Research Methods and Computer Applications

Sampling theory and techniques. Models and applications: probabilistic, deterministic. Model estimation and testing. Computer applications: simple programming, packaged statistical programs (e.g. SPSS), other useful programs. Linear programming. Dynamic programming. Individual research proposal preparation; simulation; network analysis; and applications of matrices.

Phd Studies

International Students component

Four students joined IDS in 2013 on exchange programme for mentorship under the African Leadership Centre programme, which is collaboration with the Kings College London.

Research Activities and Consultancies

In the year under review, IDS made tremendous strides in its quest to remain the premier research institution on the continent. This is manifested in some of the projects the Institute engaged in locally and internationally.

Afrobarometer

The Institute for Development Studies released the Afrobarometer Round 5 Global Release findings on freedom of speech, sources of news and information and the spread of communication technologies in Africa. The findings were released in Nairobi on October 16 2013 in a report entitled "The Partnership of Free Speech and Good Governance in Africa", authored by Prof Winnie Mitullah and Dr Paul Kamau. Some 51,605 individuals in 34 African countries were interviewed.



PIMA

The Politics and Interactive Media in Africa (PIMA) hosted a roundtable briefing and discussions at the Nairobi Safari Club in February 2013. PIMA is a research project that studied how select radio and TV stations in Kenya and Zambia reflect, gather, disseminate and influence public opinion. The objective of the workshop was to brief, share knowledge and get input from stakeholders.

Lifelong Learning for Farmers (L3F)

The Institute for Development Studies (IDS), in collaboration with the Commonwealth of Learning (COL), held a workshop on the impacts of Lifelong Learning for Farmers (L3F) initiative in Kenya and Uganda. The event was held at the Nairobi Safari Club on July 31, 2013 and brought together stakeholders in agriculture, community development, gender issues, youth and rural development.

Social Movements Study

A three-year study on social movements in East Africa was concluded in the year under review. The study, "Rethinking Social Movements in East Africa", generated knowledge on how to build and sustain social movements. It inquired into the conditions that give rise to social movements and those that lead to the fall or expiry of social movements; created the opportunity for CSO actors to interact with academia on social movements in Kenya and Uganda in order to promote healthy debates and sharing of knowledge on social movements; and generated practice-informed knowledge to help shape the form and nature of engagements between the CSOs and the society in Kenya and Uganda.

Regional Centre of Excellence for the Clothing and Textile Industries

Research carried out by the African Clothing and Footwear Research Network (ACFRN) project has underscored the need for high-level technical training for the apparel industry. Research carried out in 2010-2012, with funding from IDRC, showed that across the Eastern and Southern Africa region, most technical workers in the export clothing industry were expatriates. Since November 2012, IDS has partnered with a range of stakeholders, including the Export

Processing Zones Authority (EPZA) and the African Cotton Textile Industries Federation (ACTIF), to propose the formation of Regional Centre of Excellence for Training and Skills Development for the Clothing and Textile Industries. The proposed Centre aims to provide upto-date, relevant and practical training and capacity building for the various segments of the textile value chain in the Eastern and Southern Africa as well as for relevant institutional actors.

Youth Employment Project

The Institute for Development Studies began a collaborative research project on youth employment in East Africa in January 2013. The main objective of the regional research project is to conduct quantitative and qualitative analysis in order to identify constraints to job creation, productivity and access by the youth to employment opportunities, and identify policy implications from the results.

ACET Project

A stakeholder's conference was hosted in Nairobi in November 2013 to discuss findings on Non Motorised Transport (NMT) and Paratransit research conducted in the last five years. The research was conducted under the auspices of African Centre of Excellence in Public and Non-motorised Transport (ACET). The researchers and stakeholders exchanged ideas and made proposals for informing policy and decision making relevant for improving the urban road transport sector to restore safety and sanity.

SAFIC Project

The Successful African Firms and Institutional Change Project (SAFIC) is collaboration between Copenhagen Business School, Denmark, with the University of Dar es Salaam, the University of Nairobi, the Rosklide University and the University of Zambia.

The project, which began in January 2012, runs up to June 2016. The Kenya country study investigates food processing and the manufacture of food processing equipment.

Chronic Poverty Project

From July 2013, IDS researchers worked on a project entitled "Analysis of Poverty Reduction Policies and Outcomes" funded by the Chronic Poverty Research Centre – Kenya. Research team members were Prof Njuguna Ng'ethe, Prof Mohamud Jama, Dr Paul Michuki and Obadiah Orinda.

The research project was aimed at yielding results that help researchers, policymakers, students and other stakeholders to understand the variations in poverty reduction policies and associated outcomes and shed light on the dynamics of elements of the policy process that include inputs, outputs and outcomes of poverty reduction policies

Consultancies

During the year, IDS staff were consultants in several programmmes. Prof Dorothy McCormick was the Lead Consultant for the Nairobi portion of the World Bank's Sub Saharan Africa Transport Policy (SSATP) programme on *Mobility and Accessibility in Urban Areas of Africa*. Other consultants in the programme were Prof Winnie Mitullah, Dr Risper Orero (Kenya Methodist University) and Ms Marilyn Ommeh in the August – November 2013 programme.

Prof Rosemary Atieno participated in the validation meeting for the African Gender and Development Index (AGDI), organised by African Centre for Gender and Development of the Economic Commission for Africa in Addis Ababa, Ethiopia, between January 29-31, 2013. She was the principal consultant who prepared the Kenya African Gender and Development Index report.

Prof Atieno also conducted background country study for the 2014 Economic Report for Africa (ERA 2014). The ERA is a flagship project of the Economic Commission for Africa (ECA) produced annually.

Prof Winnie Mitullah was a Co-Investigator in the Politics and Interactive Media in Africa (PIMA) research project, which studied how select radio and TV stations in Kenya and Zambia reflect, gather, disseminate and influence public opinion.

She was Principal Co-researcher in the Youth and Unemployment: Innovative Approaches to Youth Unemployment research project. Other responsibilities were:

1. Principal Researcher: Media and Empowerment in East Africa- Researching on women and use of ICT.

- 2. Principal Researcher: EU Healthy Futures Project: Socio Economic component. A collaborative project covering the five East African countries.
- 3. Kenya Coordinator: The African Centre for Excellence for Studies in Public and Non-Motorised Transport.
- 4. Regional Director: Afrobarometer Surveys measuring the social, political and economic atmosphere in Africa.

Dr Joseph Onjala was involved in the assessment of the implementation of the African Development Bank's Involuntary Resettlement Policy to enhance the design of the integrated safeguards system (in collaboration with GIBB Africa Ltd).

In collaboration with International Labour Organisation (ILO) - Somalia Programme, Dr Onjala conducted economic evaluation of six road projects named Hobyo, Golol, Umadda, Fooniyaha, Kaah and Rahma roads.

The IDS Senior Research Fellow collaborated with United Nations Centre for Regional Development (UNCRD) to conduct capacity building activities on Environment Sustainability in Daadab, in April 2013. He further collaborated with UNCRD to conduct capacity building activities on Community Environment Management in Daadab, July 2013 as well as capacity building activities on Environment and Conflict in September.

Dr Paul Kamau was engaged as a consultant in a research project entitled "Import Structure and Economic Growth in Kenya", commissioned by Kenya Institute for Public Policy Research and Analysis (KIPPRA).

Dr George Michuki was a resource person for NACADA on the socio-economic effects of khat during a forum with the Parliamentary Committee on Khat held on Tuesday 8th, October 2013. Dr Godwin Murunga authored Mapping *Insecurity and Security Agencies in Kenya*, in March 2013. This is a consultancy Report for the Kenya Human Rights Commission and Shield for Justice.

He was the Lead Researcher for the drafting of the State of the Union (SOTU) Report to Audit and Monitor Compliance and Implementation of Protocols, Conventions, Decisions, Best Practice Standards of the African Union Member States. He resigned from project in September, 2013.

Dr Murunga was also engaged in Institutional and Non institutional Approaches to Peacebuilding research, which was supported under the partnership between the African Peacebuilding Network of the Social Science Research Council of New York and the African Leadership Centre, Nairobi.

Dr Paul Kamau received AERC Research Grant to undertake a research project on 'Accounting for Gender Gap in Youth Unemployment in Africa: The Case of Kenya'. He also got IDRC Research Grant to undertake a research project on 'Chinese Ascendancy in the Global Clothing Industry and Its Implication for African Clothing Exports'

International Links and Collaborations

In the year 2013, the Institute for Development Studies made several international links and collaborations both as a unit and through individual staff members.

Regional Project

IDS worked jointly with the Institute of Policy Analysis and Research (IPAR)-Rwanda, Centre for Basic Research (CBR), Uganda, and the Economic and Social Research Foundation (ESRF), Tanzania in a project entitled "Innovative Approaches to Creating Opportunities and Incorporating Youth into East Africa's Labour Markets." The study was launched in January 2013 to determine the sources of growth and the employment opportunities generated by such growth; explain the relationship between economic growth and youth employment and determine the potential of such employment opportunities in reducing youth unemployment.

(S-S-N) Academic Cooperation

Delegates from Bonn Rhein-Sieg University of Applied Sciences (Germany) and the University of Cape Coast (Ghana) were hosted by IDS in a workshop to explore and develop academic collaboration in various thematic areas.

The fact finding mission to Kenya, "towards a South-South-North (S-S-N) Academic Cooperation," drew scholars from BRSU's International Centre for Sustainable Development (IZNE) and UCC's Institute for Development Studies and Department of Management Studies, School of Business. The event was coordinated by Dr Joseph Onjala.

African Leadership Centre

The Institute for Development Studies maintained its collaboration with Kings College London in the running of the African Leadership Centre (ALC). The centre was established in Kenya in June 2010 as a joint initiative. The ALC is a Pan African centre of excellence on peace, security and development in Africa. It trains and mentors young Africans with the potential to lead and enable innovative change in their communities and in the region.

Centre of Excellence Committee/ Vision 2030 Collaboration

A Sub-Committee of the Working Committee on the Regional Centre of Excellence for the Textile and Apparel Industry held a consultative meeting with representatives of Vision 2030 Secretariat. The Sub-Committee paid a courtesy call to the Vision 2030 Secretariat to create awareness of the proposed centre of excellence and identify areas of collaboration. The meeting explored the possibility of making the proposed centre one of the flagship projects of Vision 2030.

SOTU Link

The Institute for Development Studies (IDS), in collaboration with the State of Union (SOTU) Coalition, hosted a public dialogue on "Pan Africanism- Are We Living the Dream?" The

dialogue brought together scholars, Pan African activists and experts, university students, policy makers and the general public to discuss issues of Pan Africanism and African Renaissance.
