RECENT SCHOOL ACTIVITIES

Contract Teachers Research Dissemination Workshop -

10th January 2014.

On 10th January 2014, the School co-organized a dissemination workshop, in collaboration with the Partnership for Economic Policy (PEP), and the Ministry of Education, Science and Technology (MOEST).

The event, entitled "Contract Teachers Research Dissemination Workshop", was held at the Nairobi Safari Club. The Contract Teachers Project evaluated several

interventions including the impact of a contract teacher on performance in randomly selected public primary schools in Kenya. The project, partially funded by PEP employed a randomized controlled trial (RCT) design. It was successfully implemented by MoEST through KNEC and a Non-Governmental Organization (World Vision). The results varied between the two implementing agents implying the challenges of scaling up learning in Kenya.

The workshop involved panelists/participants from the Kenya National Examination Council, the MOEST, Brookings Institution, World Vision and UWEZO among others. The objective was to bring together key stakeholders to discuss the research project's findings/outcomes and their implications for education policy in Kenya, and especially in relation to (and to inform) the implementation of contract teacher schemes. Mr. Paul Wasanga, CEO, KNEC delivered the keynote address.

WTO Chairs Programme Research Dissemination Workshop - 13th January 2014

The WTO Chairs Programme (WCP) at the School of Economics held a research dissemination workshop at the Chiromo Conference Centre on 13th January 2014. The workshop discussed findings from ongoing research under the programme ranging from issues in Trade, Economic Integration, Implications of mineral and oil discoveries in Kenya and Foreign Direct Investments. Related to this, Prof. Tabitha Kiriti Ng'ang'a represented the WCP at the School in the launch of a book "Connecting to Global Markets: Case Studies Presented by WTO Chair-Holders Held in Geneva on 11th February 2014". The book contains research undertaken by WCP members.
