The World Health Organisation estimates that 360 million people worldwide have bilateral moderate to profound hearing loss. 80% of these live in low and middle income countries. Most of these countries do not have national programmes to prevent and manage hearing loss.

The aim of this course is to enable participants to understand the magnitude and causes of hearing impairment and the challenges of providing hearing health in developing countries. The course will familiarise participants with public health approaches to ear and hearing health and show how to develop programmes for prevention and management at the local, district or national level.

Key Facts

- The major preventable causes of hearing impairment in low

 and middle-income countries are middle ear infections,
 excessive noise, inappropriate use of certain drugs, problems during childbirth and vaccine preventable infections.
- At least half of all hearing impairment is preventable.
- Detecting and responding to hearing impairment in babies and young children is vital for the development of speech and language.
- Properly fitted hearing aids can improve communication in at least 90% of people with hearing impairment.
- In developing countries, fewer than 1 in 40 people who need a hearing aid have one.

Accreditation and Methods of Assessment

There is no formal assessment but at the conclusion of the course a certificate of attendance will be issued.

Target Audience

This course would be worthwhile if you:

- are an Otologist, Audiologist, Paediatrician or allied hearing health professional, especially in the communication sciences, health planner or NGO worker
- are interested in starting, continuing or resuming a career in ear and hearing health in the developing world
- wish to learn about the planning principles involved in establishing public health programmes for ear and hearing health in the developing world
- are interested in working together with health workers from developing countries

Teaching

The course will be taught by lecturers and experts in the field of hearing and public health who are from, or have lived and worked in developing countries. Teaching will be conducted through a mixture of interactive lectures, case studies, discussions and group exercises. A manual and USB key with the course materials will be provided.

Aims and Objectives

The key learning objectives are to:

- understand how the principles and practice of public health apply to hearing loss
- review the epidemiology of ear disease and hearing loss globally and in developing countries
- use a public health approach to explore challenges and solutions in prevention and rehabilitation of hearing loss in developing countries
- assess the role of Primary Ear and Hearing Care and its training

- discuss how to raise awareness and mobilise resources for ear and hearing health in developing countries
- earn about community-based research on ear and hearing care in developing countries
- earn how to develop a programme for ear and hearing health in the participant's own country or region
